

# Epson Stylus Pro GS6000 Sneak Peek Road Show Trip Giveaway

## OFFICIAL RULES

This promotion will begin in conjunction with the first Epson Stylus Pro GS6000 Sneak Peek Road show event in Secaucus, NJ on July 31, 2008 and end in conjunction with the last Sneak Peek Road Show event in San Francisco, CA on October 7, 2008.

**2. DRAWING:** Attendees at each of the Epson Stylus Pro GS6000 Sneak Peek Road Shows will be entered into the contest. At the end of the seven city tour a number will be selected via a random number generator. The participant assigned to the matching number will be the winner. Purchase will not increase chances of winning. Only one entry/one prize per person. Odds of winning depend on number of valid entries. Each winner is responsible for all applicable taxes (whether local, state, federal, or international).
